In physics, acceleration is the rate of change of velocity of an object with respect to time. An object's acceleration is the net result of all forces acting on the object, as described by Newton's Second Law. The SI unit for acceleration is metre per second squared ( $\text{m}\cdot\text{s}^{-2}$ ). Accelerations are vector quantities (they have magnitude and direction) and add according to the parallelogram law.

A fictitious force (also called a pseudo force, d'Alembert force, or inertial force) is an apparent force that acts on all masses whose motion is described using a non-inertial frame of reference, such as a rotating reference frame. Examples are the forces that act on passengers in an accelerating or braking automobile, and the force that pushes objects toward the rim of a centrifuge.

What is infrared? Infrared energy is part of the electromagnetic spectrum and behaves similarly to visible light. It travels through space at the speed of light and can be reflected, refracted, absorbed, and emitted.
